

## Notice for Change in Management Fee and Front End Load (Sales Load) of Alfalah GHP Cash Fund

Further Unit Holders of Alfalah GHP Cash Fund are hereby notify that the Front End Load (Sales Load) of 0.75% have been applied on Investments and Conversion into Funds as per approved in the 7<sup>th</sup> supplementary Offering Document of the Fund, with the consent of the Trustee and SECP.
